| 1. Annual payments paid by August 1 receive a 5% tuition discount. Semi-annual payments paid by August 1/January 1 receive a 2% discount. | | | | | |
| 2. Ten (10) payments (August-May) are due and must be paid by the 1st of the month. A late fee of \$25 will be charged after the 3rd. | | | | | |
| 3. There are no discounts given for multiple children or church membership. Financial aid is based on individual need and qualifications. | | | | | |
| 4. Withdraw Policy. No fees are refunded if a student withdraws from FCA. Families are responsible for the full amount of current semester's tuition payment. Voucher recipients who withdraw are obligated to cover any lost tuition for that semester. | | | | | |
| 5. Financial Aid is based on a completed Financial Aid application with Indiana School Choice Vouchers, Sagamore Institute Scholarships for Educational Choice (SGO), and/or completed FCA Academic and Leadership Scholarship application. | | | | | |
